Project Updates

Convening

- Don announced that the results of the event scheduling poll pointed to May 17, 2024 as the date for the next convening.
- The Convening Planning Committee is still working on identifying a location, as the date needed to be established before it could explore venue options.
- The intended overall structure for the convening is to include ample time for networking, some coalition capacity-building (e.g., working on mission/vision/values), and planning to position the Coalition and its members for upcoming funding opportunities.

Governance

Steering Committee

- Don shared that the Steering Committee met its goals of not only being formed by the end of March, but also meeting before the end of March.
- The Steering Committee consists, for the moment, of Christine Carr-Barmasse (Mission:Ignite), Steve Heist (OneBridge Benefits), Shiela Kalkbrenner (Ardent Solutions), Sam Mattle (Center for Self Advocacy), Jeff Sanderson (People Inc.), and Bob Spino (Erie 2 BOCES).
- For now, the Steering Committee will meet the week before the full-member meeting.
- The first meeting was mostly orientation for the Steering Committee. Don reviewed with them the Committee's charter, the goals and measurement document created in 2021, and reviewed current financial information.

- Don noted that there is still \$70,000 available for regranting within the Coalition. Projects do need to be systems change-oriented. One framework to consider that Don likes (and that Liftoff Director Rachel Bonsignore uses in her work) is the [Water of Systems Change](#). It identifies six conditions for systems change, including: policy, practice, funding, power dynamics, relationships, and mental models. The document is oriented towards philanthropy, but the model is more broadly applicable.

Other Discussion

ConnectALL Broadband Challenge Process

- Heidi Ziemer shared a link for the NYS ConnectALL Office's webinar on the NYS Broadband Challenge, scheduled for 3:00pm on March 21, 2024. ([Slide deck](#); recording of webinar to be available under the "Resources" section of the [NYS Broadband Challenge Page](#))
- This process is important, as broadband coverage maps are often very inaccurate. If a single household within a census tract has broadband service, that entire census tract is considered to be served. This tends to overestimate coverage. The current Public Service Commission broadband map is available [here](#). For comparison, the state of Massachusetts map is available [here](#).

User Interface Challenges for Seniors

- Isaac Carrasco-Ortiz observed that the seniors he works with get frustrated using apps because user interface elements are not consistent across platforms. He was wondering whether anyone was looking at the intersections of digital equity, digital inclusion, and user interfaces.
- Several Coalition members offered to follow-up with Isaac after the meeting to discuss this issue and connect him to people who might be helpful.
