Active Project Updates

Strategic Casemaking Workgroup

- The workgroup is developing a case for digital equity to enlist people as allies and move them to action.
- Currently working on completing a draft slide deck by the end of 2024.
- Plan to share the completed deck at the January 2025 meeting.
- Progress can be tracked on the <u>shared Notion project status board</u>.

Digital Equity Stories Workgroup

- Had a productive kickoff meeting earlier this month. Established scope and timeline.
- Initial focus will be on Erie and Niagara counties.
- Working on developing:
 - Process for approaching potential storytellers.
 - Methods for story collection.
 - Systems for coding and transcribing stories.
 - Shared portal for story access.
- Once processes are established, they will be documented and distributed to enable wider participation from all Coalition members.

Grant Updates

Digital Equity Technical Assistance Fund Grant

- We received a preliminary commitment of \$100,000 from New York State.
- The scope of work included in the Coalition's proposal included:
 - Developing a centralized data repository.
 - Creation of common metrics for organizations working on broadband access, equipment access, and digital skills.
 - Western New York-wide survey on digital literacy and skills.
 - Results Based Accountability (RBA) training and certification opportunities (RBA Certified Professional, Trainer).
 - Workshops focusing on eight NTIA-identified "covered populations" with digital access barriers.

Steering Committee Updates

- Jeff Sanderson is retiring from People Inc. and leaving the Steering Committee.
- Currently seeking three new steering committee members:
 - Preference for representatives from outside Erie County.
 - Looking for more community voice on the Steering Committee.
 - Monthly one-hour time commitment via Zoom.
- Finances remain fairly stable. The majority of remaining funds are for re-granting, but need to be held back for now to cover up-front Digital Equity Technical Assistance grant expenses.

• Website revisions planned for late 2024/early 2025. The site has been fairly static for about four years.

2025 Planning

- Primary focus will be on implementing Digital Equity Technical Assistance Grant activities.
- Other key priorities include:
 - Planning Western New York convening.
 - Rolling out digital equity case making messaging.
 - Collecting digital equity stories.
 - Developing regional advocacy agenda (to complement the statewide agenda being developed through the NYS Digital Equity Network).
- We need volunteers for:
 - Results-Based Accountability certification training (Certified RBA Professional and Trainer)
 - Performance measure development
 - Convening planning committee
 - Various workgroup activities
